Call to Order/Quorum Established

Approval of the Minutes

Management/Financial Report

Barry reported that the rooftop exhaust fan was recently fix and that Aadelard Plumbing and Heating is preparing its quarterly inspection report for the Board which will be presented at the next meeting. Barry reported that the Corporation is currently on budget and no other questions were asked of him by the Board.

Moved by Daorcey, seconded by Chris that the Board engage Morrison Hershfield to produce quotes for recommended repairs to the parkade concrete and rebar and manage said repairs: carried.
- 4/ The Board discussed the security of the security camera PVR box. Barry directed to follow up with Simplex Grinnell for a quote on a more secure cage for the PVR.

5/ Tony reported to the Board that he was continuing his search for a programmable thermostat that is compatible with the electrical output in the building.

6/ The Board discussed a previous request to obtain overhead door remotes for the lower parkade. Project tabled until a later date.

New Business

1/ Tony and Daorcey note that there continues to be a sporadic problem with letting in visitors through the front door by pressing "9" on the telephone. Tony suggests it may be a short in the system. **Barry directed to have**Simplex Grinnell review the problem and provide a solution.

2/ Tony asked the Board for clarification on the quality of electrical/wiring standards in the building with concern that the electrical system may not be to code. Barry responded that the current system does meet electrical standards.
